

Addendum

This addendum sets out changes to be made in the Scheme Information Document (SID) of all the schemes of Tata Mutual Fund (TMF).

At present switch of units from one scheme to another scheme of Tata Mutual Fund is subject to minimum amount requirement of the respective switch in scheme(s). Henceforth there shall not be any minimum amount requirement in case unitholder is opting for switch of all units to any other scheme of Tata Mutual Fund, except for Tata Tax Saving Fund (TTSF) where the minimum amount is Rs 500/- and in multiples of Rs 500/- and Tata Young Citizens Fund (TYCF) where the minimum amount is Rs 500/- and in multiples of Re 1/-. The switch transactions are subject to the exit loads as applicable to the respective schemes.

Effective Date: February 24, 2010.

- This addendum will form an integral part of the SID.
- All other terms and conditions of the SID read with other addendums if any remain unchanged.
