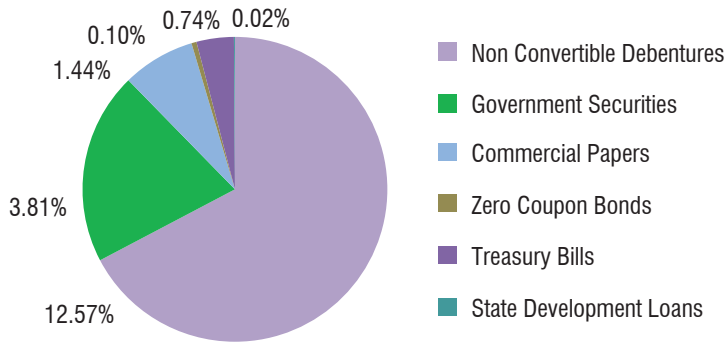

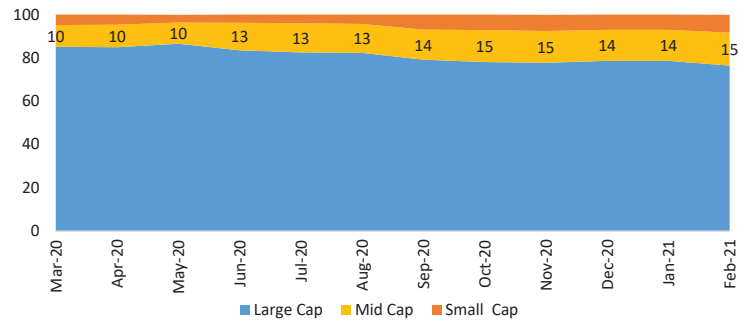

DEBT PORTFOLIO COMPOSITION

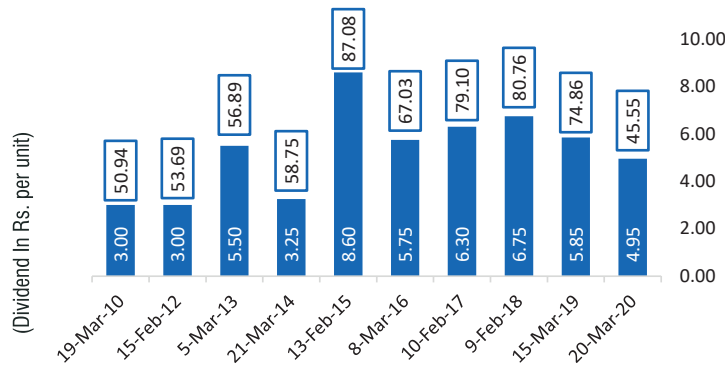


MARKET CAPITALIZATION WISE EXPOSURE

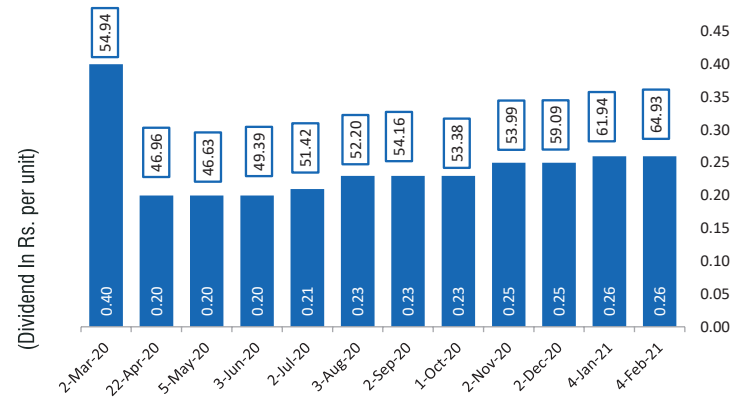
