Shariah Compliance Certificate for TATA Ethical Fund of TATA Asset Management Limited

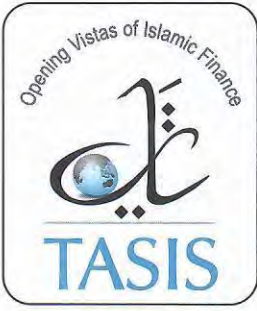
(For the Period 1st October 2020 to 31st March 2021)

Pursuant to agreement dated 19th July 2017, between Tata Asset Management Limited (TAML) and Taqwaa Advisory and Shariah Investment Solutions (P) Ltd. (TASIS), relating to ongoing Shariah monitoring and certification of the **Tata Ethical Fund (TEF)** of TAML, TASIS has scrutinized various reports, books and records pertaining to the said Fund submitted by TAML during Shariah Audit conducted **online on 31st August 2021** for the period **1st October 2020 to 31st March 2021**.

On the basis of the said Shariah Audit, I/we have the following comments on the Shariah compliance of the said Fund:

1. None of the excess funds of TEF were intentionally deployed in any form of interest-based avenues.
2. The applicable purging ratios provided through the purging report to TAML are being informed to the investors through the TAML website.
3. The stocks in the portfolio were found to be fully Shariah-Compliant during the period under review.
4. All investments of TEF, apart from deposits with banks in current accounts, were exclusively invested in equity shares.
5. None of the shares which were part of the investments of TEF were pertaining to companies from sectors which were non-compliant with Shariah.

6. The purchase and sale of shares at TEF were made in a Shariah compliant manner.
7. TEF did not indulge in transactions involving options, futures, swaps or derivatives trading of any nature.

In view of the observations noted above, I/we certify that the mode of investment and the operations of TEF have been compliant with Shariah.

On the basis of the above I/we certify that the said Fund was Shariah compliant and also proposes to comply with TASIS Shariah norms in future.
